## Annual Transportation Permit for Licensed Refuse Haulers

For Movement of Rubbish using Designated Legal Loading with reduction to Normal Legal Loading during Frost Law Restrictions

As Owner, I (we) hereby request permission to transport the following vehicle on the roads under the jurisdiction of the Road Commission and attest that these loads do not exceed 700 lbs/inch of tire width until Frost Laws, at which time, shall not exceed 450 lbs/inch of tire width or size requirements. Approval for the requested route on this application constitutes a permit in compliance with Section 722, P.A. 300 of 1949, as amended, under the following conditions and restrictions:

1. This Permit **must** be carried in the vehicle.
2. Applies to normal refuse pick up with one trip per mile per week, Tuscola County work sites only.
3. The Road Commission has the right to suspend this agreement if weather or road conditions warrant such action.
4. The permittee shall be responsible for damages to the highway, to persons, and to property caused by or arising from operations covered by this permit. The permittee shall indemnify and save harmless the Tuscola County Road Commission and all of its employees from any and all suits, claims, and damages of every kind arising out of, under, or by reason of this permit, or from operations covered by this permit.
5. Any of the following actions shall immediately void the permit and subject the applicant to appropriate legal action:
  - a. Misrepresentation of information set forth in an application for permit;
  - b. Noncompliance with the conditions, restrictions, or provisions on which a permit is issued;
  - c. A change or erasure on a permit.
6. The Weighmaster shall strictly enforce the above limits and any violation will invalidate the permit and over weights will be figured back to the legal limits for the road in question.
